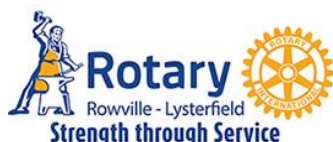

The son of one of Australia's greatest criminal lawyers, Frank Galbally, David at various times has represented Australia's leading sporting institutions including the Australian Football League and Cricket Australia. David is often called upon to comment and give his expert opinion on legal issues that arise in the media from time to time and has been a legal commentator on 3AW's Neil Mitchell program for many years.

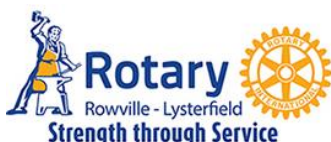
